4. Bidder must submit their complete bids electronically on or before 12:00 noon on the 2018/03/05.
5. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2018/03/05 at Buddhabhumi Municipality Office, Buddi, Kapilvastu.
6. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a Nrs. 2,50,000/- which shall be **valid for minimum 30 days** beyond the bid validity period.(i.e 120 days)
7. Bank guarantee issued by "A" Class commercial bank will be accepted.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
