- 4. Bidder must submit their complete bids electronically on or before 12:00 noon on the 2018/03/07.
- 5. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2018/03/07 at Buddhabhumi Municipality Office, Buddi, Kapilvastu.
- 6. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a Nrs. 1,80,000/- which shall be *valid for minimum 30 days* beyond the bid validity period.(i.e 120 days)
- 7. Bank gurantee issued by "A" Class commercial bank will be acceped.
- 8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
